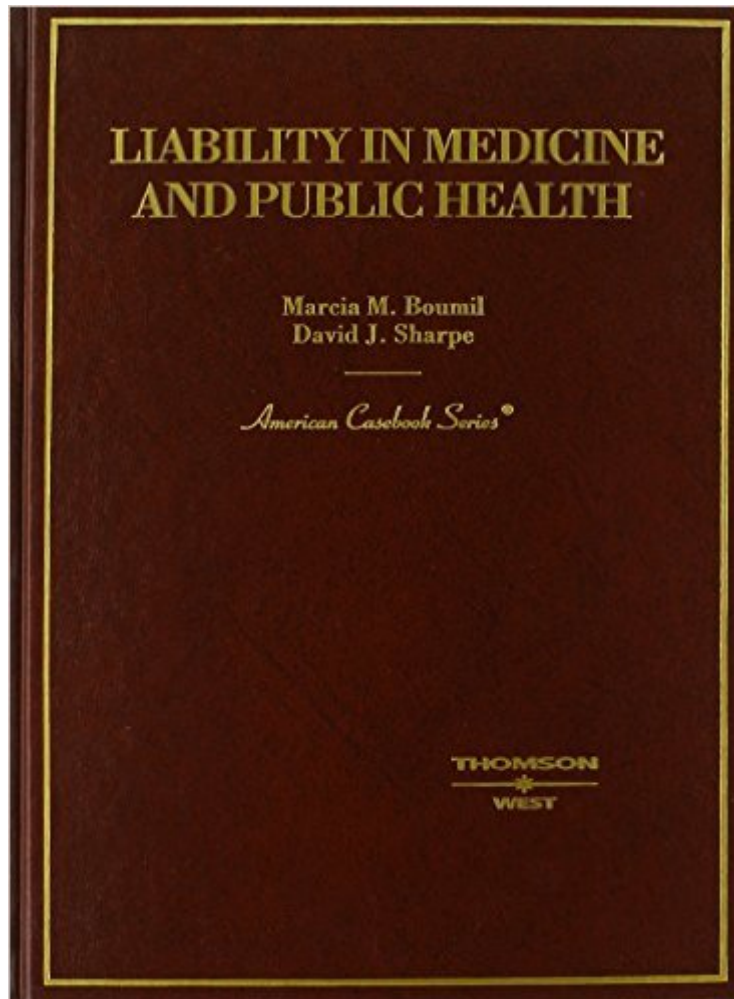

Synopsis
