

Book does not go into depth for many topics, but introduces it briefly- hence why it is an introduction. Good book to read about if you're interested or want to know more about the Paralegal profession.

The school bookstore wanted ALOT more for this book than I paid here, and I got it in 2 days. It's in excellent condition and it came with a link to free online help in this subject area. Im very pleased with this purchase.

Was foolish enough to get the kindle version of the textbook. Poor layout, omitted some of the nessasarry case briefs for my law class that were in the printed text, and had an overall scattered information base. The search tool was useless, and the table of contents were maladjudsted to the online setup. Will not be buying textbooks on any device in the future, and asking my professor to make the plain text mandatory.

I found the book to be very comprehensive. It provided a solid outline of the elements necessary in preparing for a career as a paralegal. I'm retired military with a graduate degree in HR. This book helped provide the initial guidance needed to establish a platform of understanding.

The chapters are way too long and too much broad information is thrown at you at once. There is also no summary at the end of those long chapters to help you get a brief idea of what you need to actually learn from all that information. I also think it was just poorly written and put together. Luckily I've already learned the same material in a different paralegal class I'm taking much more easily. I'm just skimming through these chapters to pass the class at this point.
